



Terra West Management is horrible and their phone system is outdated. There are so many prompts they ask you to dial and then once you connect to an actual phone, you have to leave a voicemail. Any questions or concerns have to be addressed via email (which may take awhile to receive a response).

I recently moved into the neighborhood in April of this year and the realtor gave me the keys to the pool area. However, the keys are no longer valid due to the transition of using cards to obtain access into the pool area. I was told to drive to the Terra West location on S. Cimmaron Road to obtain a key card. Upon arrival the young girl at the front desk told me that each home is assigned to 2 pool key cards and anything after that is \$5 per card. She mentioned the previous home owner may have the key card still. Isn't it Terra West's obligation and duty to obtain all key(s) once a home owner moves out? Including gate remotes and pool keys?

Anyways, I paid the \$5 with a check because she stated that they no longer accept cash or card as a form of payment. With technology advancing , you'd think this piece of shit HOA management would allow these forms of payment but apparently they're stuck in the 80/90's because they only want you to pay w/ a personal check or money order.

I came back to the office the next day with a personal check and the front desk girl processed my transaction and gave me my pool keys.

HERE'S THE SPOILER: I came to the pool hoping to gain access to the pool BUT guess what? The pool card doesn't work!!!! What a waste of time, energy, and effort! I went back and forth to that damn office just to pay for a malfunctioning key card !

I ended up having to call back and wait even longer before speaking to someone who had no clue of how to find the information I was looking for.

Also, a newsflash for Terra West....

It's 2019, most people don't even have checks anymore and money orders are obsolete!!!!! Homeowners should be able to use their debit card, credit card or the old standby CASH!!!!







This company provides poor customer service. First, we were sent a violation notice with a photo close up of my backyard. I was home alone that week as my husband was out of town. How creepy is this? Then we fixed what was asked to get a response of "Please make sure your property address is within your response for proper notation to your account." They hire retirees with low self esteem that are mad at the world, to police the community. These over zealous patrols have nothing better to do than look for frivolous "violations".

We recently sold our home due to constant harassment of letters for such violations:

1. Urine spots on the lawn from neighbors' dogs.

2. Dandelions on lawn, considered weeds

3. Tree suckers in lawn due to shallow root system of two quaking

aspens. An issue that has been going on 15 years.

4. Garbage can left out overnight, or not put back within an hour of pick up!
